## Florida Black Codes

Shortly after the Civil War, the Florida state legislature passed laws that severely impacted the lives of newly freed slaves, called freedmen. For instance, freedmen were prohibited from owning guns, and Florida legislators ignored organizations and individuals who argued that was a violation of their second amendment rights. In courts, African Americans could not serve on juries and could only testify against other African Americans, not white Americans.

"... A Florida Supreme Court justice told the legislature which passed the black codes: We have a duty to perform – the protection of our wives and children from threatened danger, and the prevention of scenes which may cost the extinction of an entire race..."

"... Provisional Governor Marvin believed that if the convention abolished slavery and guaranteed the "protection an security of the former slaves, Florida would be readmitted to the Union. He expressed the hope that with progress, improved intelligence, and civilization the freedmen might in the future become "the best free agricultural peasantry in the world. To ensure that they would be good laborers, Marvin suggested making vagrancy punishable by temporary servitude..."

"...Special punishments for freedmen were also created. When they law called for line and imprisonment, there was super added the alternative of thirty-nine lashes, standing in the pillory, or both. The discrimination, the legislature claimed, was based on the difference in the two races. 'To degrade a white man' by whipping would make a bad member of society; to fine and imprison a Negro, on the other hand, would punish the state rather than the individual. Furthermore, to imprison a Negro petty offender would mean his withdrawal from the plantation, but whipping meant a speedier return to work..."

"...Four types of offenses were made punishable by death: inciting an insurrection, administering poison, burglary, and rape of a white female..."

No greater duty nor greater responsibility could be accepted by the American people, than the assurance to our self and our posterity than these principles and development of an educational program of enlightment to all America. As far as the negro is concerned America must face the fact that God Almighty never intended racial equality for negros and whites. The negro is the problem of America, not the problem of the (communist) and we should give him (the negro) all privileges we can, but never in a million years should we give our white daughters, and we as white people should face squarely the issue that intermarriage and a racial equality is impossible in the north or in the south.

The negro is separated from the white race by a racial barrier of his color (given him by God) and he has remained black for many centuries while in contact with the white race and civilization. His color completely bars any thought of social equality and the mental development of the nigroid race can never be overcome by communism. Jude 7: Even as Sodom and Gomorrah, and the cities about them in like manner, giving themselves to fornication and going after strange flesh, are set forth for example, suffering vengance of eternal fire. God segregated the earth to his liking and tells us to segregate in the Bible (even the negro knows that, just ask him), yet the supreme court is not educated to the point of knowledge that God alone is supreme. The Jewish amalgamaters in this country are out to destroy us. We will not sell our free white American birthright for what little they have to offer.
